### IMPORTANT NOTICES:

Transfer forms must be completed in full and paid in full before they will be processed.

Blackfish Armory will only accept shipments from, or send shipments to a federally licensed Collector, Dealer, Distributor or Manufacturer of firearms.

Blackfish Armory will only send a signed copy of its Federal Firearms License to other license holders.

A valid, state-issued photo identification (ID) must be furnished to photocopy for attachment to the completed paperwork at time of filing. The ID furnished must reflect the individual's current residential address, or an additional form of ID (which is acceptable as a form of ID for a background check) must be furnished which contains a name matching the state-issued photo ID & reflects the individual's current residential address (current utility bill, lease agreement, etc.)

#### Inbound (Receiving) Specific Notices:

Blackfish Armory reserves the right to refuse refund to any customer who transfers in a firearm and is denied on their background check. Blackfish Armory is not an importer of firearms and will therefore only accept firearms from any of the 50 United States and the District of Columbia. (Note that this excludes any US possessions and territories such as Puerto Rico, The Virgin Islands, Guam, etc.)

Inbound transfers will only be processed for: Virginia residents with valid ID & military personnel with valid ID and official orders stationing them in Virginia.

Customers understand that an inbound firearm is not ready to be picked up once it has been delivered, but only after they have received a phone call indicating it is ready. Once this notice has been given, it may be picked up any time during business hours.

Packages containing firearms received from non-licensed FFL holders will be returned to the sender.

#### Outbound (Sending) Specific Notices:

Blackfish Armory is not an exporter of firearms and will therefore only ship firearms to any of the 50 United States (excluding California) and the District of Columbia. (Note that this excludes any US possessions and territories such as Puerto Rico, The Virgin Islands, Guam, etc.)

Outbound transfers will only be processed for: Virginia residents with a valid ID; military personnel with valid ID and official orders stationing them in Virginia; and out-of-state residents (including residents of the District of Columbia) purchasing a handgun through Blackfish Armory (as per the Gun Control Act of 1968).

Customers must furnish their own shipping boxes except for out-of-state residents purchasing a handgun through Blackfish Armory.

Blackfish Armory will not ship any of the following items: ammunition; cases, or any other items, accessories, etc., other than what will fit inside the customer-furnished shipping box.

### FIREARM TRANSFER FEES

#### Inbound (Receiving) Fees:

Receiving fee is \$50 for the first firearm and \$10 for each additional firearm received from the same licensed collector, dealer, distributor or manufacturer at the same time as the first.

**If this completed form is not received by Blackfish Armory before the firearm is received, the transfer fee will be \$100.**

An additional fee of \$2 is charged for the state background check.

#### Outbound (Sending) Fees:

Sending fee is \$50 for the first firearm and \$15 for each additional firearm going to the same licensed collector, dealer, distributor or manufacturer at the same time as the first - PLUS:

**Any Long Gun:** (Unwrapped or in a soft case going to)

Eastern US (Eastern Time Zone): **\$35\***

Central US (Central & Mountain Time Zones): **\$55\***

Western US (Pacific Time Zone): **\$55\***

(\* denotes UPS Ground ONLY; Next Day fee is \$90; any long gun in a hard case is an additional \$25 charge.)

**Any Handgun:** All handguns go UPS Next Day Air, **no exceptions. \$50 PLUS:**

Eastern US (Eastern Time Zone): **\$45\***

Central US (Central & Mountain Time Zones): **\$65\***

Western US (Pacific Time Zone): **\$85\***
